#### **Description:**

This meeting we are debuting a new format for our council summary sheets. The primary reason for the change is to save staff time. Previously, staff spent hours making separate color copies for each agenda item for the Council packet. With the reduction in staff in the Office of the City Manager, this is no longer a good use of our resources.

Moving forward, each section of the agenda will have a different color of header:

- Presentation Lavender
- Public Hearing Orange
- Consent Calendar Cream
- Reports Burgundy
- Action Blue
- Information & Discussion Green
- Work Session Tan

The summary sheet has also been reorganized to include 1) "budget/fiscal impact" section rather than the previous accounting sections which were confusing and rarely used 2) a sample affirmation motion to assist the Council in formulating motions.

As the Council and staff gain experience with the new format, we will solicit feedback and potentially make additional changes.

The new format will save staff time and reduce the need to order and maintain a large stock of colored paper.
