#### **Description:**

The 2019 City of Platteville budget, as proposed by the Common Council, has a Revenue and Expense Budget for the General Fund of \$8,379,826 and a Revenue and Expense Budget for all funds of \$15,535,610.

The Council proposed budget includes the following adjustments to the City Manager budget which was reviewed by the Council on October 16, 2018:

#### General Fund Revenues

- \$6,508 net increase due to adjustments in budgeted amount of state municipal services aid and state personal property aid
- \$13,000 decrease in General Fund levy allocation to account for move of City Hall CIP Phase II design costs from 2020 CIP to 2019 CIP

#### General Fund Expenses

- \$1,348 net decrease due to various minor adjustments
- \$7,856 net increase in City Manager Contingency to account for above increase in revenues and decrease in expenses
- \$13,000 decrease in City Manager:Wage/Benefit Contingency to account for move of City Hall CIP Phase II design costs from 2020 CIP to 2019 CIP

#### **CIP Fund Revenues**

 \$13,000 increase in CIP Fund levy allocation to account for move of City Hall CIP Phase II design costs from 2020 CIP to 2019 CIP

#### **CIP Fund Expenses**

 \$13,000 increase in Capital Projects: City Hall to account for move of City Hall CIP Phase II design costs from 2020 CIP to 2019 CIP

The proposed tax levy remains at \$4,450,757 with \$2,722,546 allocated to the General Fund, \$44,647 to the Taxi/Bus Special Revenue Fund, \$1,486,964 to the Debt Service Fund, and \$196,600 to the Capital Improvement Fund. The City assessed tax rate is \$7.73 per \$1,000 assessed value, a 4.9% decrease from last year.

Staff recommends the Common Council make a motion to approve the 2019 Budget Resolution No. 18-24 in the amount of \$15,535,610.

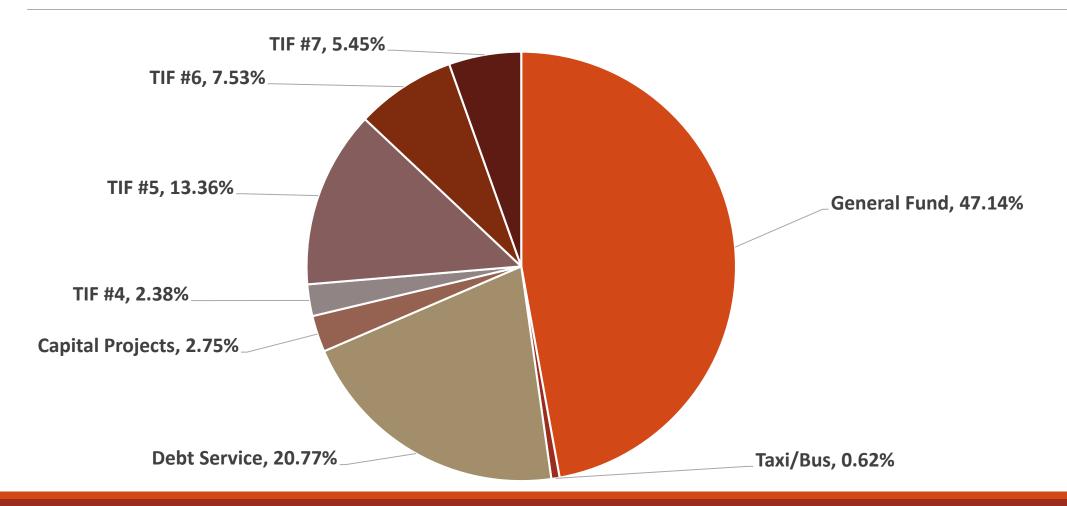

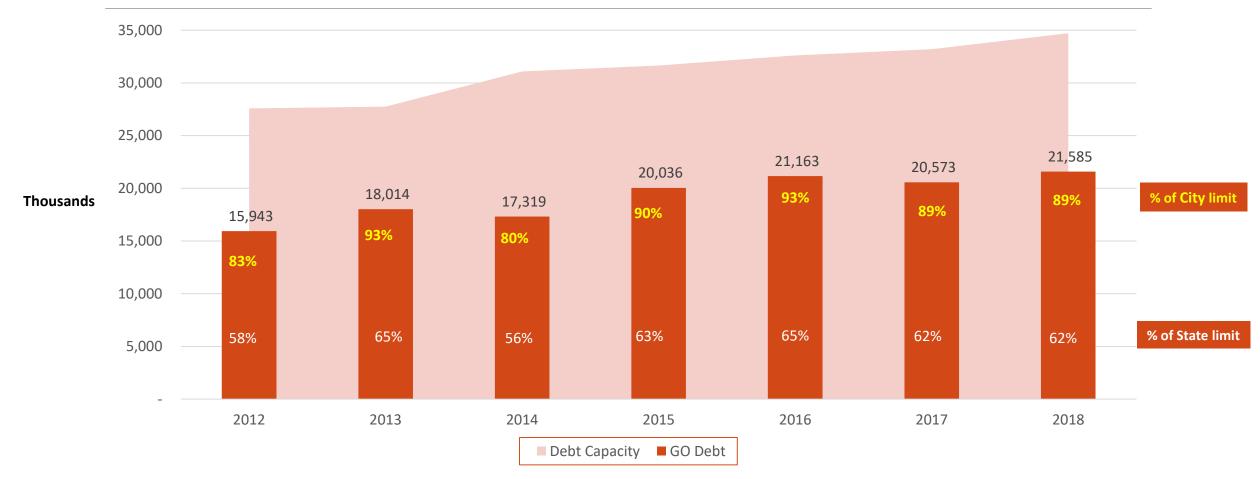

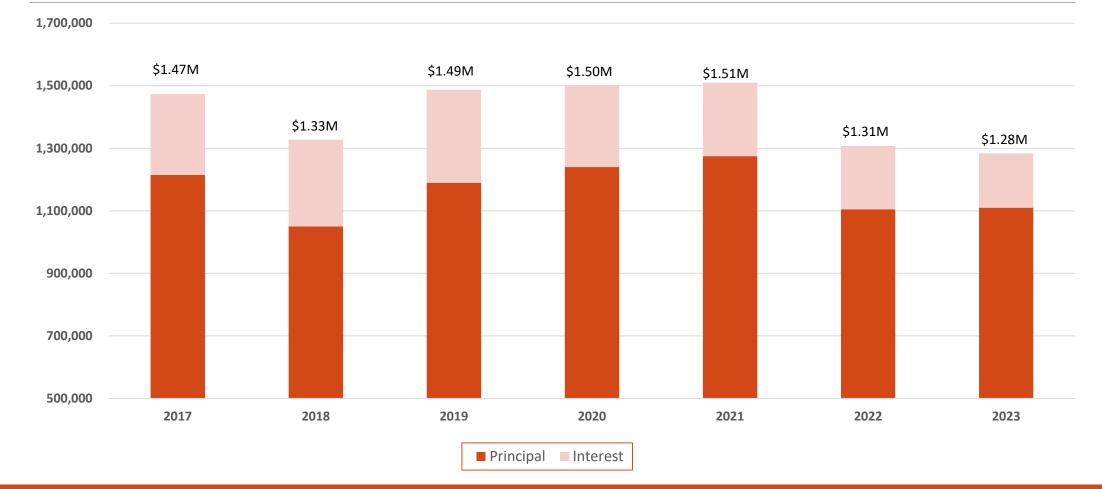
### 2018 Tax Revenue Distribution



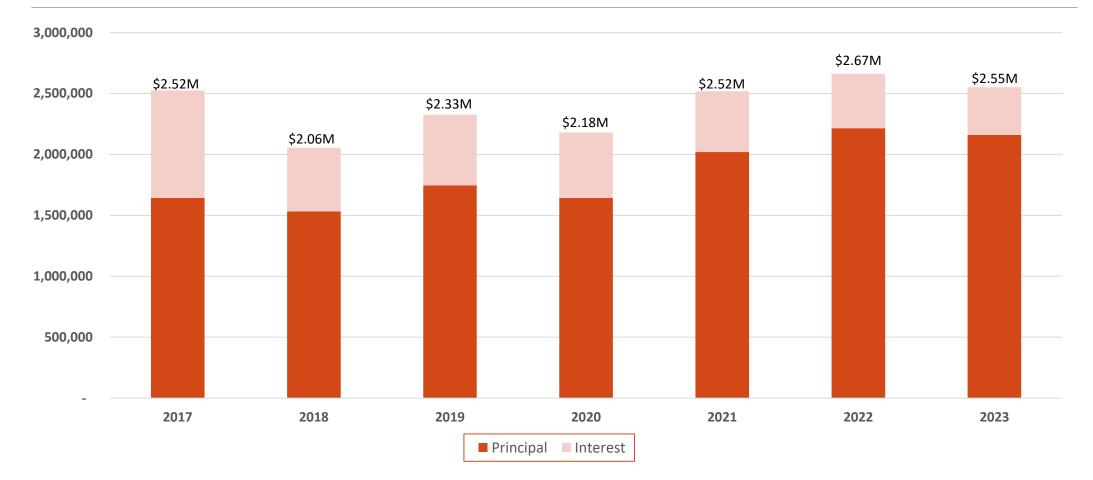
### **General Obligation Debt**

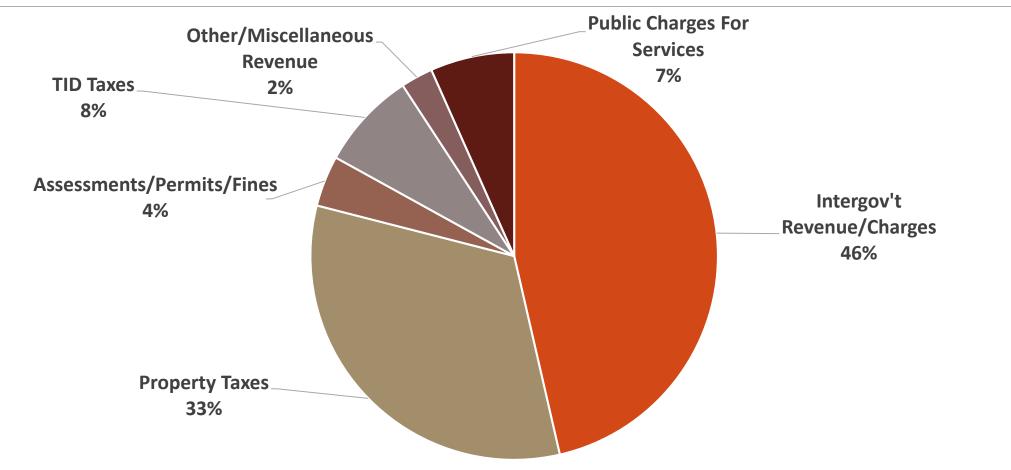

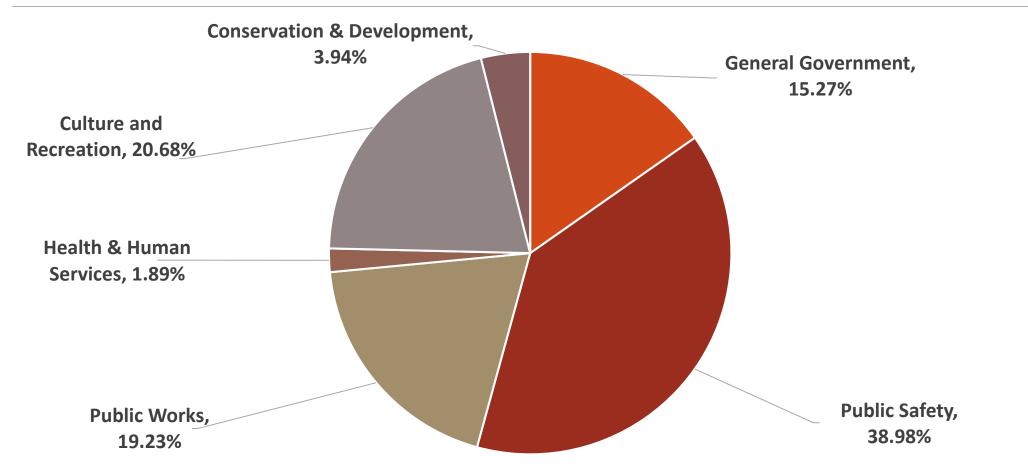

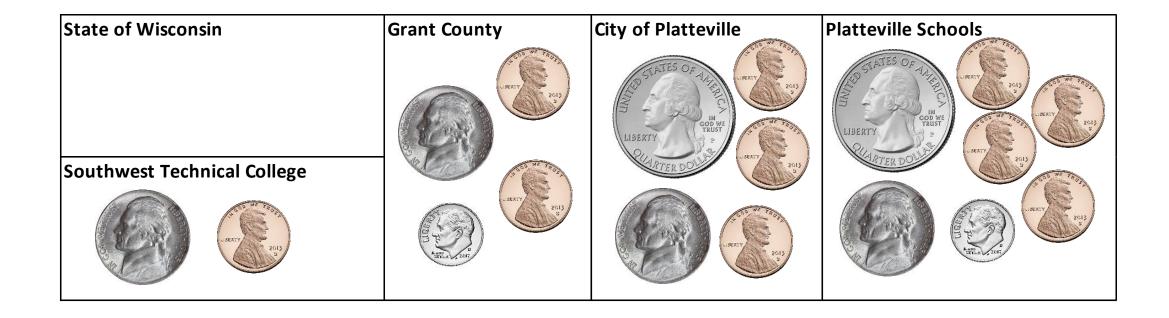
An owner of a \$150,000 home would pay \$1,160 in City property taxes, down \$60 from \$1,220 in 2018.

City property taxes on a \$162,480 home are estimated to be \$1,257, an increase of \$37 compared to last year.

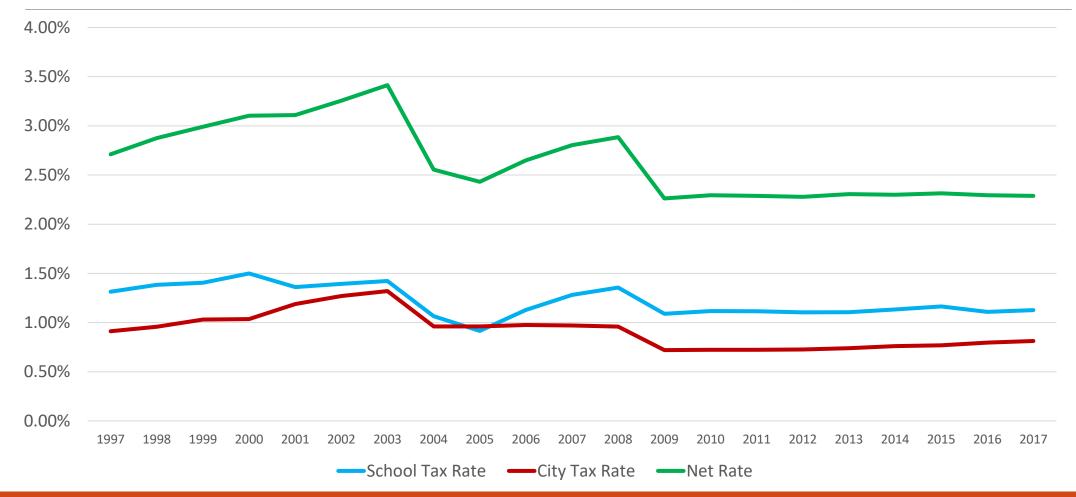
## Break Down of Tax Dollar

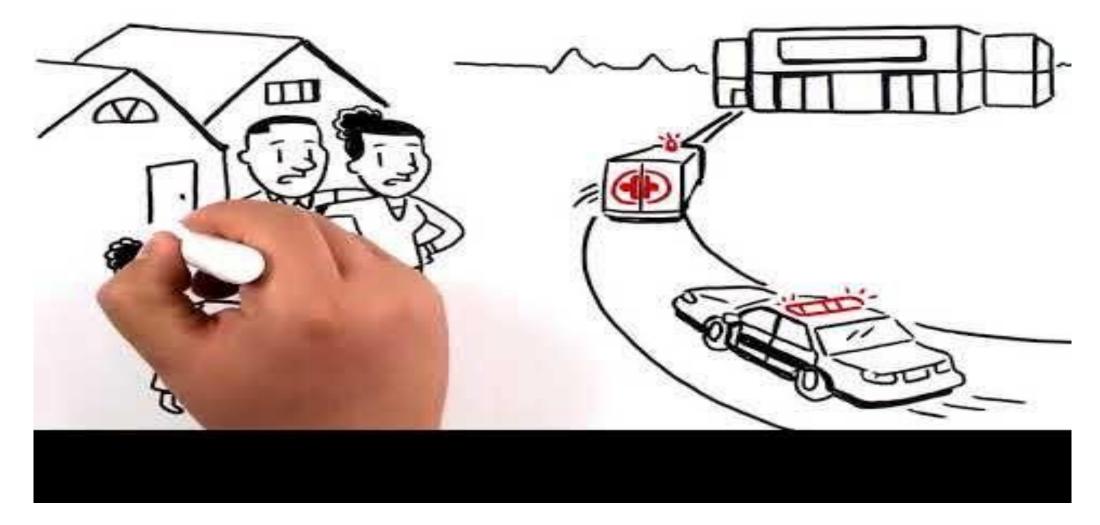

The 2019 Salary Resolution reflects a 2% base increase, as well as the following changes that occurred during 2018:

Addition of custodian positions,

Addition of Building Maintenance Specialist (NE3) position and elimination of the position of Assistant to the Public Works Director (NE3),

Addition of the position of Community Development Specialist/Planner (E8) and elimination of the position of Assistant to the Community Development Director (NE3), and

Addition of the position Police Office Coordinator (NE3) and elimination of the position of Police Office Manager (E8).

In addition, the position of "Recreation Coordinator" is proposed to be retitled to "Parks and Recreation Director" and raised one grade from E8 to E7. This change better reflects the actual duties of the position which includes serving as the liaison to the Parks, Forestry and Recreation Committee; oversight of the Aquatic Center and Senior Center staff; forestry; and strategic initiatives such as developing the Parks Master Plan and replacement of the Art Hall facility.

No step increases are planned during 2019, unless previously committed in an offer letter.

4. When considering a Conditional Use permit, consideration must be given to the standards listed in Section 22.13. Specifically, this section allows for the issuance of a Conditional Use

Permit when it is shown that the "uses and structures are in accordance with the purpose and intent of (the Zoning) Ordinance and are found not to be hazardous, harmful, offensive, or otherwise adverse to the environment or the value of the neighborhood or the community." The proposed signage appears to be in compliance with these requirements.

5. Due to the distance the house is set back from the street, the allowable wall sign would not be easily visible. The proposed sign would be visible from the street but would not be excessive for that location.

## IV. STAFF RECOMMENDATION

6. Staff recommends approval of the Conditional Use Permit to allow a 3' x 4' free-standing sign for the home occupation real estate business at 755 Lancaster Street.

Motion by Daus, second by Stockhausen to approve Original Class B Regular Liquor License to be issued to Jeff and Lisa Haas with the condition that all inspections are completed and passed, including building inspection, fire inspection, and inspection by the Department of Revenue, and that all fees are paid. This license is to be issued to the location of the upstairs approved portion of 130 Market Street. Motion carried 7-0 on a roll call vote.

Local Historic Designation Community Development Director Joe Carroll explained that the owners of the property at 280 Division Street have applied to have the property designated as a local historic structure. A Local Historic Structure means any improvement which has a special character or special historic interest or value as part of the development, heritage or cultural characteristics of the City of Platteville, state or nation. If approved, the owner of the property shall not reconstruct, alter or demolish all or any part of the exterior of the property or construct any improvement on the property unless a Certificate of Appropriateness has been approved by the Historic Preservation Commission. Demolition of a designated structure also requires approval of the Plan Commission and Council. The Historic Preservation Commission and staff recommend approval.

- I. Membership Update
  - Currently we are at 59 members out of 60 on our current membership roster.
  - A few training classes have already started with most of the firefighter courses starting in October to include:

- II. Reports of Significant Service Calls
- Currently at 138 calls for the year. This time last year we were at 109 calls for the same time period. This is a 26.6% increase in calls over last year. Two months ago, we were 21.9% up from last year. Information Updates
  - We are continuing to move forward with creating, equipping and training a Rescue Task Force for the City of Platteville. This is a joint venture between Police Dept., Fire Dept. & EMS. Police Dept. recently received a \$1000 grant from Kwik Trip towards the equipment and the Fire Dept. has received \$1000 from a donation as well as \$5000 from a donation. The Fire Department is also in the process of writing a \$6000 grant towards the equipment.
  - The Fire Department recently received an \$88,900 joint grant with Potosi Fire and Lancaster Fire towards Wildland Firefighting Protective Gear. This will provide us with 41-44 full sets of Wildland gear with just a 10% match of approximately \$2,850.

- 2. CSRC membership
  - a. Welcome to Danica Larson, new CSRC member
  - b. Recommendations for one opening
- 3. Approval of Minutes September 16 meeting motion to approve as written by Robin, second by Danica, motion passed unanimously.
- 4. Citizen Comments, Observations, & Petitions
  - a. Jeni Ginter Lyght lives on Madison Street, east of Water Street and the roundabout. Her children and others who walk between their home and the Middle School and are experiencing a difficult time crossing as pedestrians through the roundabout. The main pedestrian flow is from the sidewalk on the north side of Madison Street, through the crosswalk south and then crossing Water Street at the south crosswalk. Traffic volumes are high in am and pm peaks, when they are traveling to/from school and there are not sufficient gaps for them to cross at the crosswalk. Vehicles are creating a second turn lane to enter the roundabout to turn right. There are many auto drivers on their cell phones. This is also right near the high school, so many high school drivers are going through this intersection. Jenny has spoken to Councilwoman Eileen Nickels and is hoping that the City can address this concern. She recommends adding a crossing guard to see if this helps. Other ideas include: pedestrian flags, driver education. Please see attached document for written email from Jeni sent to Howard on 10/16/18.
  - b. Cindy Tang Cyclist crash at the crosswalk on Furnace Street at the intersection with Chestnut Ave. at approximately 4 pm on October 11, 2018. The police report has not been completed and details of the crash are not final. Cindy's employee saw the crash occur and states that the auto vehicle turned right into the cyclist who was crossing at the crosswalk along Furnace Street, traveling south. It appeared that the auto vehicle did not see the cyclist using the crosswalk. Kate Westaby provided bicycle and pedestrian crash data and crash location map for the City of Platteville from January 2010- Sept 2018. The City will try to get crash details for the crashes and Kristina can ask UW-Platteville students to analyze the data to look for any trends.
  - c. Kristina and Danica witnessed a bicycle pulling a wheelchair down Camp Street one morning.

### 5. Old Business

a. Camp Street bicycle and pedestrian accommodations:

- i. Traffic data Kristina update the speed data provided to us was poor, as the majority of the data lacked a date, location, and/or time. Of the 'good' data on Camp Street from Lancaster Road to Western, four studies had an 85<sup>th</sup> percentile speed greater than 29 mph. Looking at all data from Lancaster Road to Western, the 85<sup>th</sup> percentile speed was 27.5 mph.
- School district feedback on cost share Howard update Howard has spoken with Kris Brown of the Platteville School District and they are in support of the \$5,000 cost sharing for the sidewalks along Camp Street.
- Status on sidewalk with City budget Howard update the sidewalk is currently part of the City Manager's budget proposal to Council. The proposal is for \$48k City, \$12k match (\$5k Platteville School District and \$7k City designated funds for Camp Street improvements in 2018).
- iv. Curb ramp on Camp Howard update Gary Lindahl (citizen on Camp Street) did address City Council about his concern that the curb ramp on the east side of Lancaster Road at Camp Street does not exist. This ramp would be installed as part of the Camp Street sidewalk proposed in the 2019 budget and so this concern would be addressed as along as this sidewalk does get approval for installation in 2019.
- v. Ped flags:
  - reflective tape Howard update Howard will ask City staff to add the tape.
  - 2. drain holes in holder Howard update Howard will ask City staff to drill the drain holes.
  - 3. free standing holder on north side of road Howard will ask City staff to create (modify the existing) and install the free standing holder.
- vi. Westview dropoff/pickup Danica updated the CSRC on the Westview PTO's concerns with the congestion occurring during the dropoff/pickup at Westview Elementary School, especially present in the afternoons.
  - 1. They have created an approved of a handout/document providing four alternatives to help improve the situation (alternate driving routes, alternative pedestrian routes, using the free school shuttle, and carpooling).
  - 2. There was a PTO discussion/suggestion to create a 'No Parking or Standing During School Hours 7:30 am – 4:30 pm' along the north side of Camp Street from Western Avenue to Kelly Avenue, as there is typically a traffic queue of auto vehicles as they wait to pull into the Westview driveway and this is resulting in unsafe pedestrian crossing across Camp Street. Motion by Kristina, second by Robin for City Staff to investigate the proper language and communication needed/and timing to work with the residents on Camp Street whose parking would be impacted. Motion passed unanimously. The PTO will speak with the Westview Principle, Platteville School Superintendent Connie Valenza and Platteville School District Transportation Leader Kris Brown prior to the City connecting with the residents on Camp Street.
  - 3. There was a PTO concern stated that if additional autos did use the suggested Union Street route to get their children to Westview, that there

could be an increase in auto traffic at the intersection of Union Street and Perry Drive. Currently there is no stop sign on Union Street as it continues to the west at Perry Drive, which could be a safety issue. It was suggested that a supplemental warning sign be added to the existing stop sign at Perry Drive at Union Street that states Cross Traffic Does Not Stop'.

Hello Howard,

I am following up on the public input I provided at last night's community safe routes meeting. I thought best to send my comments to you since you are the staff liaison. I also emailed Eileen and Don prior to the meeting.

We purchased a home on East Madison in June of this year. We expected the volume of traffic on this road, but not the pedestrian issues we've been experiencing at the roundabout.

Our two children walk from PMS to our home. Our oldest child walks home after her activities. I walk up to meet our younger son at the roundabout. In the first two months of school, there have been a few near misses. Our greatest concern is when vehicles stop/yield for pedestrians in the roundabout, but vehicles behind the stopped vehicle make a new lane (to the right) around and speed up to exit the roundabout. Most vehicles do not yield to pedestrian traffic, but that appears to be the norm in our community.

I'd like the city to consider the pedestrian traffic in this area and explore some options. We are the third new home owners on our block this year alone. Plus, Lutheran Street is full of kids. We are excited to see all of the home ownership in our area. Home ownership is so good for the community.

I pulled some data from WisDot. The East Madison/Water Street intersection is labeled/identified as having a large number of vehicles per day (2001-14,800). There is also a heavy youth density surrounding the blocks of East Madison based on census data.

I pointed out, during my public input, that we also looked at purchasing property in Lancaster. Lancaster has a total of eight (8) crossing guards.

Thank you for the committee's time.

### **Description:**

Staff received a request to review the speed limit on Mineral Street to help pedestrians safely cross the street between Jenor Tower and Jenor Park.

Staff reviewed the situation and agrees that 15 mph is an appropriate speed based on the narrow street, the parking and other congestion in the area. It also makes sense based on the posted speed limit for Main Street one block south. To be consistent, this speed limit should be applied from Water Street to City Park at Bonson Street.

There should be a study of the actual traffic speeds to confirm that reducing the speed limit to 15 mph is consistent with State and engineering guidelines. Staff is working with students from UW-Platteville to do speed studies. While incomplete, the preliminary results seem to indicate that a 15 mph speed limit is appropriate.

## **Budget/Fiscal Impact:**

Speed limit signs will need to be added at appropriate intervals from Water Street to Bonson Street. This would be absorbed in the Street Division sign budget.

### **Recommendation:**

That the Common Council approve the enclosed Ordinance to reduce the posted speed limit on East Mineral Street from 25 mph to 15 mph

15 MPH on East Mineral Street from North Water Street to North Bonson Street.

<u>Section 3.</u> City staff are authorized and directed to take all action necessary to implement this ordinance, including the installation of appropriate official traffic signs.

Henry Kleinhammer, such as the short Ionic porch columns, the Palladian inspired window in the gable end and the sidelighted entrance door play an important part in this design. The classical design elements of sidelighted entrance doors and a Palladian influenced window are important features in the vernacular brick Wilson Cunningham house of 1906 on Market Street (GT 36-33) and the brick 1908 George Barden house of vernacular design at .280 Division Street (GT 26-33), both constructed by the J. M. Rose Building and Contracting Company. 104 Elaborate clustered Tuscan column porch supports are additional elements of classical influence in the Barden house. In the same period, Robert Speer, the president of the State Bank in Platteville, built a more elegant brick interpretation of the late Queen Anne style with short, Ionic porch columns and stick detailing in the gable ends at 175 South Chestnut Street (GT 25-7).

#### Styles of the Early 20th Century

The period revival house dominated the early 20th century residential construction in America. Popular periodicals such as <u>Country Life</u> encouraged American taste for revival styles and provided illustrated designs. Catalogs of house plans and Sears Roebuck pre-cut components could be ordered by anyone everywhere in America. However, a reaction against the decorative styles of the 19th century existed simultaneously with the popular taste for traditional architecture.

When the zinc era ended in 1917, the economy of Platteville became depressed. As a result, evidence of the more substantial period revival houses popular in America during this period is limited. The Georgian "Colonial" house with a gambrel roof at 410 West Mineral Street (GT 36-28) is a symmetrically designed house with a pedimented gable roof over the enclosed entrance visually supported by pilasters to either side of the entrance door. The aim of the 20th century architect of historic styles was not correctness in style so much as a creative reuse of the old historic style and details. In the Brown house on Main Street (GT 40-4) constructed in 1907, the colossal pedimented portico projects from the facade as found in the Georgian Revival house of the 20th century.<sup>105</sup> However, the remainder of the structure is, for the most part, free of historic ornament. More commonly, in Platteville, the neo-classical details of the Greek and Roman historic styles have been applied to the simplified 20th century house form. The American foursquare styled houses at 260 Division Street (GT 26-34) and 125 Washington Street (GT 34-6) have pedimented roof dormers and Tuscan column porch supports. The "modern" 20th century house of W. N. Smith at 155 Bayley Avenue (GT 24-13) designed by the Miller, Fullenwider and Dowling architectural firm in 1915 has Tuscan columns supporting the gabled entrance portico<sup>106</sup> while Ionic columns support the segmental arched roof of the entrance portico of the 1920s Frank Burg II house at 485 West Main Street (GT 40-8).

Evidence of the co-existing reaction against historical styles in the early 20th century appears in a few houses in Platteville. The American bungalow and the Foursquare appeared during the first decade of the 20th century when public taste was undergoing a reaction to the decorative excess of the Victorian Era. The number of this type of house in Platteville is small in proportion to the total number of houses, probably due to the depressed economic condition of the town after the early 20th century "zinc boom" dissipated. The bungalow style, a link to the American Arts and Crafts tradition which flourished briefly in the early years of the 20th century, was built in a variety of materials and styles but usually had a low Platteville was fortunate to have local men, an architect and a building firm, who contributed to the architectural heritage of the city.

# The Rose Company, Carpenters, Builders and Contractors

J. M. Rose, a prominent contractor and builder of Platteville and a native of Roseville, Ohio, was born in 1845 and arrived in Platteville in 1849.<sup>65</sup> Early in his life, he learned cabinet making with W. and J. Grindell of Platteville. Later, he learned the carpenter trade from which he expanded to the business of contracting and builder. The J. M. Rose firm, drawing its own plans and specifications, is credited with many residences, such as the houses of William Rindlaub, B. F. Huntington, H. E. Stephens and Thomas Jenkins.<sup>66</sup> J. Marion Rose, carpenter, is listed in the State Gazetteer as carpenter from 1886 to 1903.<sup>67</sup> J. M. Rose died June 13, 1910<sup>68</sup> in Platteville.

At the turn of the century, Rose's eldest son, John W., joined the firm, then known as J. M. Bose and Son.<sup>69</sup> A few years later the concern was called Rose Brothers. The following 20th century structures were built by the Rose Building and Contracting Company: Platteville High School (Hanmer Robbins School) at 405 East Main Street (GT 3-3), 1905, 71 Wilson Cunningham house on Market Street (GT 36-33), 1906, 72 the M. S. Sickle house at Main and Hickory, 1906, 73 the O. E. Gibson house at 620 West Ridge Avenue (GT 33-20), date unknown, 74 the <u>George Barden</u> house at 280 Division Street (GT 26-33), 1908, 75 Platteville Carnegie Library at 190 Market Street (GT 1-29), 1914, 76 and the W. N. Smith house at 155 Bayley Avenue (GT 24-13), 1915. 77

#### Henry Kleinhammer, Architect (1861-1948)

Apprenticed to a builder at age 12 in his native Germany, Henry Kleinhammer immigrated to America on February 18, 1883.<sup>78</sup> Drawn to Platteville where his half-brother lived, Kleinhammer worked as a carpenter. He advertised in the <u>State Gazetteer</u> as a carpenter from 1888 until the turn of the century when he took the licensing exam to become a certified architect.<sup>79</sup> Kleinhammer is listed as an architect in the <u>State Gazetteer</u> for several decades beginning in 1901.<sup>80</sup> Insurance sales added to his income in the 1920s. Kleinhammer designed his home at 430 East Main (GT 3-6) in 1904 where he lived until his death in 1948.<sup>81</sup>

Reported by his daughter Martha Kleinhammer to have designed structures as far away as Chicago, Henry Kleinhammer is known to have designed the following additional structures in Platteville: Platteville High School (Hanmer Robbins) at 405 East Main Street (GT 3-3), 1905; the Frank Burg house at <u>315 West Main Street</u> (GT 2-11) c. 1900-1908; and Heiser Hardware at 175 West Main Street (GT 38-7).<sup>82</sup> Kleinhammer also designed many structures in the area. Some of these are: Rewey (WI) School, 1910;<sup>83</sup> Cobb State Bank at Cobb, Wisconsin, 1910;<sup>84</sup> Benton (WI) Municipal Building, 1917;<sup>85</sup> the Palace Garage at Benton, Wisconsin, 1920<sup>86</sup> and the Asylum near Lancaster (date unknown).<sup>87</sup> Kleinhammer's public buildings show neo-classical and early modern influences; however, the frame house he designed for himself at 430 East Main (GT 3-6) is primarily of the picturesque Victorian style with Gothic Revival influences.

Platteville also has an interesting subgroup of intact clapboard-clad T-plan, cruciform plan, and rectilinear plan Queen Anne style houses that are notable because they all have encircling verandas that possess either one or two curved corners. These include:

Nearly all the above listed houses are clad either completely or partially in wooden clapboards, the partial examples being usually also clad in wood shingles as well. Brick-clad Queen Anne style examples, on the other hand, are much less common in most Wisconsin cities of a size comparable to Platteville. Thus it is surprising that Platteville possesses a number of fine examples besides the two belonging to the Burg brothers that were mentioned above. The earliest identified example is the Thomas L. Clearly House located at 435 W. Main St. in the proposed W. Main St. Historic District, which was built in 1888-1889.(13) Another early example is the house located at 385 N. Second St., which was built between 1895 and 1908 and most probably nearer to 1895, based on stylistic grounds. Still another early example is the house located at 180 W. Pine St., which is still largely intact today despite the addition of a large Georgian Revival style wing across its east elevation, which occurred after the house was converted into a funeral parlor.

Ironically, one of the latest of Platteville's brick-clad examples is a stylistic throwback to earlier designs, this being the Robert Speer house located at 175 S. Chestnut St., which was built between 1908 and 1915 and is considered to be a contributing resource in the proposed Division St. Historic District.

Platteville also has two examples of Queen Anne style houses that were built out of rock-faced concrete block as well. These are both later examples and are located at 270 Market St. and 465 N. Second St.

# 7 DESCRIPTION

General character, building types, styles, environment, important natural and man-made features, qualities that distinguish district from surroundings, nature of intrusions, and generally excepted properties.

The Division Street Historic District is a residential district comprised of nineteen single family homes and the district is located two blocks south of the NRHP-listed Main Street Commercial Historic District, which is the principal historic commercial district in the city. The proposed district consists of both sides of the 300 block of Division St. and it also includes six houses that are similar in size and quality that are located on both sides of S. Chestnut St., which intersects the east end of Division Street. Land at the east end of the district slopes slightly to the south but is flat elsewhere the boundaries. Most of the district's houses share uniform setbacks from the district's tree-lined streets and most have landscaped yards that are characterized by grassed lawns, ornamental shrubs, and mature trees.

All of the houses in the district were built between 1894 and 1926, and most of them are still largely intact. Three of the four oldest are Gable Ell form houses, the fourth is an example of the Two-Story-Cube vernacular form. Seven of the other sixteen are examples of Queen Anne style designs, seven are examples of the American Foursquare style, and there is a single example of the Bungalow style as well. Most of the district's buildings were originally clad in clapboards and several still retain their original cladding, while four others are clad in brick.

The eighteen contributing houses in the district are notable within their local context for being good representative examples of the several styles that are present, for their locally significant owners, and especially because they exhibit a noticeably higher degree of integrity than the houses of similar vintage and size that surround them. Some of the houses in the larger residential neighborhood that encircles the district were also once distinguished by their size and quality design as well, but many of these houses have now been altered as the neighborhood has transitioned from being primarily an owner-occupied single family neighborhood to one that is increasingly dominated by non-owner-occupied rental housing. Consequently, the still mostly owner-occupied houses in the proposed Division Street Historic District form a cohesive turn-of-the century ensemble that now sets them apart from the altered neighborhood that surrounds them.

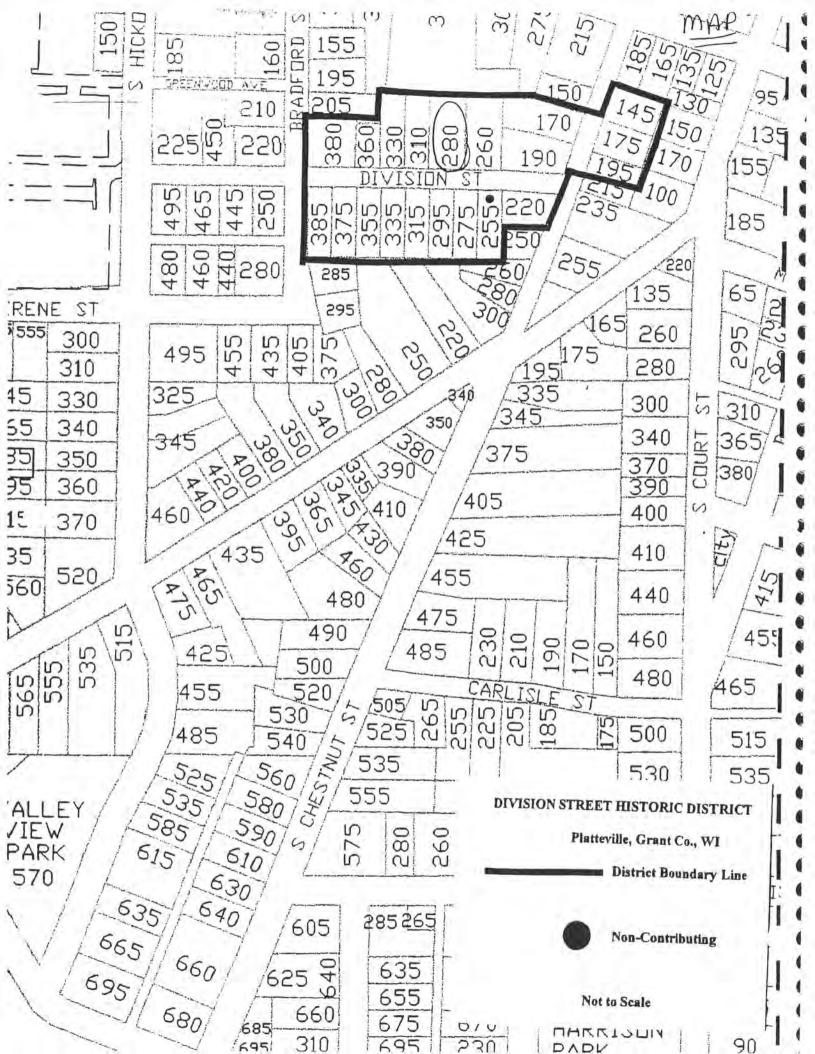
The Division Street Historic District is believed to be of architectural significance under NRHP Criterion C because it contains one of Platteville's most significant and intact collections of Queen Anne style and early Progressive style residential buildings. The district contains nineteen houses, fourteen of which are good examples of the Queen Anne and American Foursquare styles, and all of which were built between 1894 and 1926. The plat in which these houses are located, however, is much older. Henry's Addition was platted by George W. Henry in September of 1858, and the plat was then and still is located just two blocks south and west of the city's historic business district. It was not until the 1890s, though, that houses began to be built here. Up until that decade, residential construction in the city mostly took place north of Pine Street a block to the north, but Platteville's population grew from 2900 in 1892 to 3800 in 1900, with much of this growth happening in just the last three years of the decade. Not surprisingly, this rapid growth placed an enormous burden on the city's existing building stock and resulted in new construction in parts of the city that had not previously been developed.

The evolution of the district and the growth Platteville experienced during this period corresponded to the revitalization of Platteville's mining industry, which centered on the mining and processing of zinc ore and began around 1900. The rapid growth that the city experienced during this period led to a building boom throughout the city but especially in the areas south of East and especially West Pine Street that had not experienced substantial growth before. Evidence of this can be seen by looking at the 1896 Bird's Eye View of the city, which shows that very little development had occurred south of Pine Street by that time. Soon thereafter, however, those wanting new houses began to buy and develop lots in existing plats such as Henry's Addition that had never been developed or else they built on new lots that were created when new plats were developed.

Many of these new houses were built for merchants and professionals whose places of business were located a few blocks away in the downtown. The district's earliest houses were Gable Ell form houses that were constructed in 1894-1895 and once building in the district began, lots in the district filled up quickly. By 1908, all but three of the district's thirteen houses on Division Street had been completed. In contrast, only one of the six houses in the district that are located on S. Chestnut St. was built before 1906, this being the Two-Story-Cube form Van Etta House at 220 S. Chestnut St., built in 1895-1896. Four of the other five were built between 1906 and 1915, however, while the last one, the John Hemphill House at 145 S. Chestnut St., was built in 1921. Thus it can be seen that the large majority of the houses in the district were built between 1894 and 1915, which accounts for the stylistic unity that the district displays.

The district and the surrounding neighborhoods, which were also comprised almost exclusively of single family residences, remained stable for many years. By the late 1960s, however, the neighborhood surrounding the district was beginning to change, in response, primarily, to the growth of the student body of what had become the University of Wisconsin-Platteville. What had up to that time been primarily single family houses were now increasingly becoming rental properties that catered to the University's student body and the prestige and desirability that had long clung to the district and the surrounding area diminished as a result. Today, however, theses houses are once again being valued for their quality construction and superior design. Individually, most of the district's buildings are fine representative examples of their particular styles. Collectively, they are also of significance to the history of Platteville because these buildings illustrate the evolution of architectural design

in Platteville during the period of significance. The Division Street Historic District is thus believed to be eligible for inclusion in the NRHP at the local level primarily because of the individual architectural significance of the buildings it contains, but also because they constitute a largely intact ensemble of buildings that is evocative of the period during which they were built.

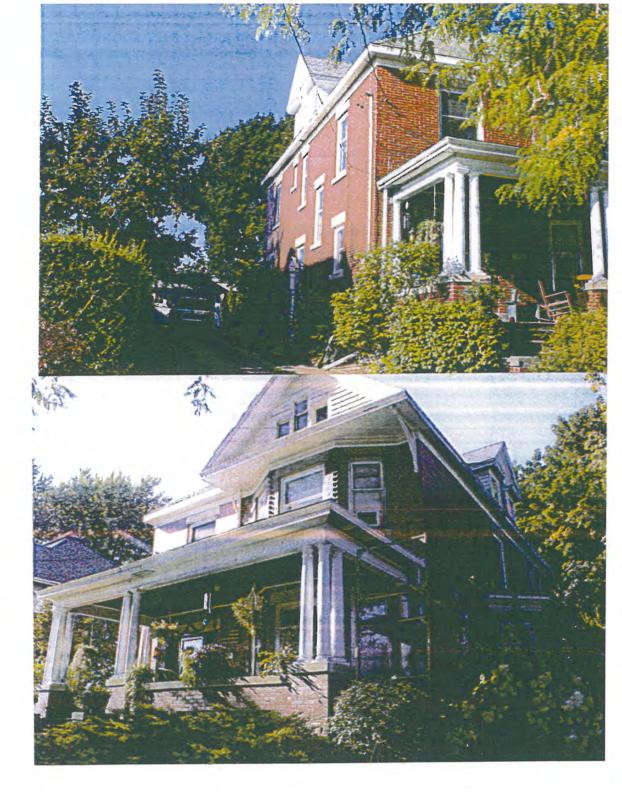

## **Description:**

The Word of Life Church was founded in 1981 and is currently located in Dubuque, Iowa. The church is growing, and they would like to open a campus of the church in Platteville. Initially, they would like to lease space in the building at 55 S. Court Street but would eventually like to find a more permanent home. This property is the former location of the Platteville Senior Center. The building has been vacant since the Senior Center relocated to the OE Gray Building in the fall of 2017. The City sold the building to RJAJ Properties in October. The applicant would like to lease the building from the owner for use as a church, which requires a conditional use permit.

The anticipated initial congregation in Platteville is approximately 40 adults, plus children. The building would be used for Sunday morning church service, as well as some days during the week for music practice, meetings, fellowship and outreach activities. The property has four parking spaces on-site, with additional parking available in the public parking lot on the east side of the post office and on the streets.
