PEDESTRIAN WAITED AT THE INTERSECTION FOR THE TRAFFIC LIGHT AND WALK SYMBOL. UPON SEEING THE WALK SYMBOL, PEDESTRIAN CROSSED THE STREET AND STAYED IN THE CROSSWALK. UNIT 01 WAS DRIVING WB ON W MAIN ST. UNIT 01 TURNED SOUTH ON STH81 AND DID NOT YIELD TO THE PEDESTRIAN IN THE CROSSWALK. UNIT 01 STRUCK THE PEDESTRIAN. Driver of Unit 01 was Cited.

 - a. Police Department presentation of Crossing Guard deployment of Lancaster Street in fall 2025.

- b. Transportation Alternatives Program (TAP) 2026 2030. Municipalities, School Districts and Non-Profit Organizations are eligible to submit grant applications to WisDOT by October 31, 2025, for grants in 2027 and beyond for pedestrians and bicyclists.
 Potential grants include: Moundview Trail Connection – Phase 2, Phase 3, Phase 4; Dog Park to Skate Park trail; Valley to Eastside trail; Staff requests prioritization.
- c. Pine Street Pedestrian Islands: At the July 8, 2025, Common Council meeting, the Draft Minutes from the June 25, 2025, CSRC Special Meeting were presented. The CSRC recommendation was as printed in the Minutes. The Common Council directed that the three Pine Street Pedestrian Islands be replaced with 8-foot-wide islands and that a crosswalk be painted at the intersection of Court and Pine.
