1. Call to Order at 6:00 pm by Cindy Tang

- 2. Approval of Minutes: January 16, 2023 meeting: Motion to approve as written by Robin, second by Eileen. Motion passed unanimously.
- 3. Citizen Comments, Observations, & Petitions:
 - a. There were concerns about enforcement of shoveling sidewalks.

4. Old Business:

- a. TAP Planning Grant: Howard said there is still no signed agreement from the DOT, but he did have a conversation with DOT rep Travis Houle. Mr. Houle is to confirm that we can contract directly with SW WI RPC without a formal selection process.
- b. STARS Grant: Howard and Robin were on the conference with reps from the WI Bike Federation. They reiterated the desire for Platteville to submit grant requests despite the City being over 5,000 population. The Bike Federation will provide a recommendation whether to ask for a full grant again or break it up into phases. If in phases, it would be 3 phases: 1 - From the JN railroad bridge at the paved trail up to Mitchell Hollow Road. 2 – From Mitchell Hollow Road to Broadway/County B. 3 – From Broadway/County B to Fairfield Drive north of the High School.
- c. South Chestnut Street (Gridley to Harrison): Howard provided updates.
 - i. East side from Harrison to Gridley: \$ 63,000
 - ii. East side from Gridley to Richard: \$ 65.500
 - iii. East side from Richard to Dodge House apartments: \$192,500
 - iv. Total on east side from Harrison to Dodge House: \$321,000
 - v. West side from Harrison to Gridley: \$238,000
