  - a. Paul mentioned that the RRFB advance warning flashers time out after about 5- 8 seconds while the RRFBs at the crosswalk stay on for the requisite time.
  - b. A note from a member of the public that there are no crosswalks to cross South Chestnut Street south of Southwest Road until you get to Rountree Commons. There are also concerns about the stairs on Alden Avenue.
