1) Call to Order: The meeting was called to order at 6:00 pm.

2) Welcome new members:

3) Approval of Minutes:

a. A motion was made by Eileen to approve the July 21, 2025 minutes, seconded by Angela. Motion passed. There was no quorum for the August meeting.

4) Citizen Comments, Observations, & Petitions: **Connie noted a section of sidewalk missing on Bayley Avenue in the first block south of Pine Street.**

5) Old Business

- a. Bike-Pedestrian crash history follow up discussion. **None in July or August.**
- b. 2026 DNR Maintenance grant follow up. **Howard clarified that the grant request was capped at \$100,000 with seven locations identified for repairs. The trail would be made to current standard at those locations – 10 foot paved width, etc. Anticipate grant award announcement in September or October.**
- c. Bike-Pedestrian plan review. **Howard to send a link to new members Angela and Connie.**
- d. Pine Street Pedestrian Islands. **As of September 5, all islands were constructed, painted and signs installed. Howard showed photos of the island at Oak Street and the new painted crosswalk at Court Street.**
- e. Jewett Street crosswalk. **This was the crosswalk requested by the Police Department. More children cross Lancaster Street at Jewett Street than at Camp Street. The PD requested a painted crosswalk at Jewett Street to coincide with moving the crossing guard to Jewett Street. Howard reported that the crosswalk was painted and signs installed prior to school.**

Cell 911. Complainant stated an individual on a bike was struck by a motorist, and the motorist was upset about the situation. A second call was received from an alarm company, indicating a motorist needed assistance. Officers responded and were advised two individuals had been riding bikes in the road on Water St., and were not visible to the motorist, who struck one of the individuals, causing a minor injury. Both bicyclists were issued written warnings for failing to use lights while riding during darkness, with a fix date for both of 9/29/2025. A DT4000 will be completed. acd.

Ofc Stowe confirmed written warnings were satisfied. pam

On September 15, 2025, I, Officer Larissa Klemm, was working as a police officer for the Platteville Police Department within the City of Platteville, County of Grant, State of Wisconsin. I was wearing my full duty uniform and operating a fully marked squad car.

Initial Incident

At approximately 7:59p.m., I was dispatched to an accident on Water St. at Cedar St. Dispatch advised that it was a bike vs. car accident, but there were no injuries at the time. Arriving on scene, I activated my body camera. I spoke with Steven Boudreau first. Steven was the driver that had struck two bicyclists that were traveling in the center of the road without lights. Steven advised he was driving Northbound on Water St. and went to turn left onto Cedar St. When turning left, he struck two bicyclists. Steven advised the bicyclist were not visible and he did not see them. The bikes or bicyclists did not have any lights or reflective gear on. Steven advised the male driver swerved out of the way and he had just brushed the side of his car and the female had went over part of the hood. There was minor damage done to Steven's vehicle, Sgt. Purkapile took a photo of the damage. Steven's vehicle had brush marks on both the drivers side and passenger side vehicle. Steven said that he had stopped his vehicle when turning to attempt to avoid the accident. He advised most of his car was still in the lane traveling northbound and part of his vehicle was in the other lane to turn. When he was completely stopped, the bicyclists did not slow down and struck his vehicle. Steven said the male was riding his bike near the center line and the female was traveling closest to the side of the road. Each bicyclists went on each side of his vehicle. The female had struck part of the front of his vehicle before landing to the side of the road, on the West side of Water St. near Cedar St. Steven parked his vehicle on Cedar St. and both bicyclists moved the bikes to the sidewalk.

██████████ was identified by WI DL and ██████████ was identified verbally. ██████████ was not injured. ██████████ had ██████████. I asked if she wanted any medical attention, she advised she did not. ██████████ advised they were driving Southbound on Water St., when the driver turned and struck them. ██████████ advised they were in the road, but that was okay. ██████████ also said they were going pretty fast and his bike did not have brakes so he could not stop. I asked if they had any lights on their bikes, neither did. I had both ██████████ and ██████████ call a parent when on scene and inform them what had happened. I asked if there was any damage done to their bikes. Both ██████████ and ██████████ said they did not have any damage done to their bikes. I took pictures of ██████████ and informed them they could go home. Both individuals were told to stay off the road until they added both front and rear lights to their bike.

██████████ was an individual unrelated to the accident, but stayed on scene until we arrived. I asked ██████████ if she witnessed what had happened. ██████████ advised she did not and was driving by when she saw ██████████ on the ground. ██████████ advised ██████████ was on the ground near the sidewalk on the West side of Water St., with her bike. ██████████ had his bike already off to the side on the sidewalk. ██████████ advised she stopped because both parties were arguing and Steven seemed upset so she stayed to make sure that nothing happened after the accident. I thanked ██████████ for staying and ended my contact.

A DT4000 was filled out.

Both ██████████ and ██████████ were provided written warnings for operating the bikes without proper lighting.

Follow-up

On 9/16/2025, I called both parents of the juveniles involved in the crash and left a voicemail asking for a call back. I also called Steven to provide him with an incident number for the crash since he left the scene before being provided one. Steven was door dashing and said he did not have a pen and paper to write down the number. After I ended my contact with him, I texted him the incident number. During the phone call, Steven informed me that he had his damage quoted for his vehicle and it was approximately \$1,000.

On 9/19/2025, I had not received a phone call back from ██████████ or ██████████. I called both individuals again. ██████████ answered and she was informed that ██████████ would be receiving a written warning for

operating his bike without lights. She was informed if he did not fix the warning he would receive a citation. Both [REDACTED] and [REDACTED] never called back. I wrote a letter and explained the written warning.

Both written warnings and drivers exchange forms were mailed on 9/21/2025.

This ends my involvement with this incident.
