Minimum Specs for a Regenerative Air Street Sweeper

Intent

It is the intent of these specifications to describe a regenerative air street sweeper with hydraulic drives, wide pickup head. The head must be capable of sweeping in reverse with the head down without causing damage to the pickup head or its components. Blower shall be belt driven via auxiliary engine. The unit must be equipped with vertical digger-type gutter brooms, pressurized dust control spray system and an independent engine to power the sweeping functions. The chassis for this sweeper is to be sufficiently rated to transport a full load of sweeping debris. For safety and comfort of the operator and for quick, local service along with local availability of repair parts.

- 1. **Engine:** An auxiliary diesel engine shall be provided to power the sweeper. The engine shall be a John Deere turbo charged four-cylinder with Tier IV final emission with a horsepower rating of not less than 134 hp @ 2400 RPM and shall provide a peak torque rating of not less than 398 ft/lb at 1,600 RPM. Minimum displacement shall not be less than 275 cubic inches, or city approved equal.
- 2. **Brooms:** Segmented brooms on both left and right side with in cab tilt, geo, and variable speed-controlled brooms.
- 3. **Dual Controls:** Sweeper must be able to be operated from either the left or right side.
- 4. **Brakes:** Vehicle must be equipped with disc brakes or air brakes. For safety, loss of engine power shall not automatically engage brakes.

- 7. **Hopper:** The hopper body structure, excluding the inlet and outlet wear tubes, water nozzles and mounts, deluge plumbing, hand hose components, and suction screens, shall be warranted against rust perforation and corrosion perforation for the "LIFETIME" of the sweeper, as defined as the ownership period by the original purchaser of the new sweeper. Hopper shall be equipped with body vibrator.
- 8. **Hopper Screens:** Hopper screen to be a high strength stainless steel, two-piece saw-tooth design such that airflow will not be interrupted even in difficult sweeping conditions. Screens should be equipped with remote dropdown screens.
- 9. **Water system:** min 250 gal. made of non-rusting material. Water fill gauge visible from normal operating position. Sweeper shall be equipped with automatic internal hopper or flushing system.

- 10. **Electrical:** Shall be a 12volt system, with a 120 Amp alternator. Shall have resetting circuit breakers. All lights shall meet DOT standards using LED lights. All wiring shall be identified by color code and by word coded wires. All gauges, switches, and instrument panels shall have internal illumination.

Minimum Specs for Mechanical Street Sweeper

Intent

It is the intent of these specifications to describe a mechanical street sweeper with a dust suppression system. The unit must have segmented brooms on both left and right side with in cab gutter broom tilt and adjustable pressure.

- 1. **Engine:** Diesel with Turbo. Must have engine shutdown in case of low oil pressure or high coolant temperature.
- 2. **Brooms:** Segmented Brooms on both left and right side with in cab tilt heads and adjustable pressure. Main broom must be hydraulically controlled with adjustable pressure.
- 3. **Dual Controls:** Sweeper must be able to be operated from either the left or right side
- 4. **Brakes:** Vehicle must be equipped with disc brakes or air brakes. For safety, loss of engine power shall not automatically engage brakes.
