

FALL CLEAN-UP

Monday & Tuesday, Sept 28 & 29, 2026

- Please have items on curbside by 7:00 AM on your normal trash pickup day and no earlier than September 27.
- No loose items. Please bag or otherwise contain the garbage.
- Please stack items in a pile no larger than 10x4x4 and neatly. Scrap metal should be stacked separately.
- Brush and Yard waste are included in clean-up. Please have items to curb by Sunday evening and placed separately from weekly garbage. Platteville \$1.00 bags are not required for fall clean-up.
- This service is provided to one & two family dwellings only.
- Prohibited* items will NOT be picked up:
 - oil
 - tires
 - batteries
 - anti-freeze
 - insecticides
 - hazardous chemicals
 - any and all electronics
 - appliances (including microwaves)
 - debris from major construction or remodeling

YARD WASTE DISPOSAL & WOOD CHIPPER

Yard Waste pickup is on Thursdays during the spring, summer, and early fall. The wood chipper will circle the town during the weeks of the first and third Mondays of the month.

- Yard Waste must be placed in \$1.00 Platteville bags or bio-degradable bag marked with a sticker & placed at curb for pick up. Bags & stickers may be purchased at City Hall Finance office, Hermesen's Hardware, or Piggly Wiggly.
- Please have your brush to the curb by Sunday evening.
- The chipper can take limbs up to 12 inches in diameter and should not be larger than two people can handle.
- Brush and limbs must be placed at the curb with the cut end toward the street and stacked in a neat and orderly fashion. Larger limbs should be grouped together and placed separately from the smaller brush piles. Brush piles will not be picked up until they are piled correctly.

NO PARKING ALONG SNOW EMERGENCY ROUTE

When will my street be plowed? It depends on the priority of the street. It could be very soon if you are on a major street or could be up to 12 hours for a small cul-de-sac. If there is continuous snow over a long period of time, it could be even longer. The goal is to have all roads passable within 24 hours regardless.

Why did you plow snow at the end of my driveway? Snowplow drivers are responsible for removing the snow from the public street. The property owner has the option to remove all or part of the snow at the end of the driveway as needed for access to the house or business.

Will the City remove the snow from the end of my driveway? No. The owner must remove the snow.

Can I put the snow back in the road to have the plows take it somewhere else? No. It is illegal to place snow back in the street. The fine for a First Offense is \$50.00. The only exception is in the Downtown area where residents are allowed to place snow from the sidewalk at the curb for removal.

Where can I park during a snow storm? The best place to park is in your driveway. If there is no room, the next recommendation would be on a wide street that has alternate side parking. This will allow enough room for vehicles to park and plows to clear the main portion of the street.

Do I have to shovel my sidewalk? Yes, the entire width and length of the sidewalk must be cleared of snow and ice within 36 hours after the end of a snow event. This includes shoveling out to the cleared portion of the street at intersections.

What will you do about a damaged mail box? If you have a mail box that meets US Postal Service guidelines (6" behind the curb) and it is damaged by a snowplow, the City will replace it in kind. Replacement mailboxes will be installed in accordance with US Postal Service guidelines. If your mail box is in violation of the guidelines and is hanging out beyond the curb and it is damaged, it will be your responsibility to replace it. Please check it now to make sure it is 6" behind the curb.

What if my lawn is damaged by snowplows? In the spring, the Street Department will look for obvious areas that were damaged and repair them. If you notice something, please call the Street Department at 348-8828, or e-mail: sengn@platteville.org.
